TERMS AND CONDITIONS FOR NETWORK MEMBERSHIP

§ I. Networks for Attorneys and Jurists, Support Networks, Client Networks

International Legal Association (ILA) maintains several Main Networks comprising reputable attorneys, jurists, and organizations specializing in various fields of law. The purpose of these networks, as well as the overall structure, is to facilitate international collaboration and ensure consistently high professional levels.

ILA also maintains several Support Networks comprising reputable providers of business-to-business services and products of significant value to attorneys and jurists. The purpose of these networks, as well as the overall structure, is to strengthen the competitiveness of the members of our main networks.

ILA also maintains several client networks comprising organizations and individuals who have a legitimate interest in the services offered by ILA, its members, and/or its Main Network Members.

§ II. Network Services

Network Members enjoy privileged access to various information products and services as may be offered from time to time, subject to the Programs and Benefits Chart and the Terms and Conditions for Network Programs.

§ III. Main Network Members

Section 3.01 Eligibility Requirements

Eligible to become a Main Network Member (MNM) is any individual who, in the opinion of International Legal Association (ILA):

- 1) Is a an attorney, a jurist, or a member of the legal profession in some other capacity;

- 2) In rendering services, is willing and able to make a good faith effort to ensure a consistently high quality and an overall satisfying experience for other MNMs and their clients; and
- 3) Has paid any applicable fees.

Section 3.02 Network Membership Fees

- 1) Any new MNM shall pay a 1-time, non-refundable enrollment fee and an annual, non-refundable maintenance fee.
- 2) ILA shall not collect referral fees or similar forms of remuneration from an MNM, whether in relation to incoming or outgoing referrals, within any of its networks. An MNM may be asked to pay an administration fee, if applicable, in connection with referrals requiring extensive work by ILA.

Section 3.03 Trial Network Memberships

ILA is entitled to waive the enrollment fee and/or the annual maintenance fee for up to 12 months. Where such fees are waived, the network membership is considered a Trial Network Membership, subject to the following conditions:

- 1) The MNM may cancel at any time during the trial period without further obligation;
- 2) A Trial Network Membership may be terminated by ILA at any time without notice if an eligible service provider who offers similar services applies to become a MNM and to pay any applicable fees as stipulated in Section 3.02;
- 3) A Trial Network Membership is automatically terminated when the Trial Network Membership period expires.

§ IV. Support Network Members

Section 4.01 Eligibility Requirements

Eligible to become a Support Network Member (SNM) is any individual, corporation, or other business entity that, in the opinion of ILA:

- 1) Is a provider of business-to-business services that may be of significant usefulness to at least one Main Network Member (MNM); and
- 2) In rendering such services to MNMs, is willing and able to offer significant discounts, rebates, and/or other terms which are more favorable than those offered to regular business consumers of like services; and
- 3) In rendering such services, is willing and able to make a good faith effort to ensure a consistently high quality and an overall satisfying experience for the MNMs; and

- 4) Does not offer services that directly compete against similar services provided by an existing SNM on the network in question; and
- 5) Has paid any applicable fees.

Section 4.02 Network Membership Fees

- 1) Any new SNM shall pay a 1-time, non-refundable enrollment fee and an annual, non-refundable maintenance fee.
- 2) ILA shall not collect referral fees or similar forms of remuneration from a SNM. Any administration fees, if applicable, shall be paid in full by the MNM.

Section 4.03 Trial Network Memberships

ILA is entitled to waive the enrollment fee and/or the annual maintenance fee for up to 12 months. Where such fees are waived, the network membership is considered a Trial Network Membership, subject to the following conditions:

- 1) The SNM may cancel at any time during the trial period without further obligation;
- 2) A Trial Network Membership may be terminated by ILA at any time without notice if an eligible service provider who offers similar services applies to become a SNM and to pay any applicable fees as stipulated in Section 4.02;
- 3) A Trial Network Membership is automatically terminated when the Trial Network Membership period expires.

§ V. Client Network Members

Section 5.01 Eligibility requirements

Eligible to become a Client Network Member (CNM) is any individual or organization who, in the opinion of International Legal Association (ILA):

- 1) Has a legitimate interest in the services offered by ILA, its members, and/or its Main Network Members;
- 2) Has paid any applicable fees.

Section 5.02 Network Membership Fees

- 1) Any new CNM shall pay a 1-time, non-refundable enrollment fee and an annual, non-refundable maintenance fee.
- 2) ILA shall not collect referral fees or similar forms of remuneration from a CNM. Any administration fees, if applicable, shall be paid in full by the MNM. ■
